Parish Stewardship

This year St. Julie Billiart celebrated its 40th anniversary. When plans for the celebration began, it was quickly apparent that St. Julie's full history had never been properly recorded. Sharon Aeria, Director of Communications and Development, wanted to be sure the parish history, especially stories from the original founders, was recorded for generations to come.

Funds were granted in 2013 for the Historical Multi-Media Project which took pictures, old booklets, founder interviews, etc., and digitized them into the first repository of parish history. "Everyone at St. Julie has come with a story," said Sharon, "and this was our chance to capture and share those moments."

Through the process of interviewing their founders, so many wonderful stories have been shared about the early days of St. Julie. One of these interesting stories is that the church construction was not yet completed when the first Mass was held 40 years ago! Stories such as these will be included in the book of St. Julie History that Sharon and her team are currently working on.

This project shares the theme of the Anniversary Mass: Past, Present, and Future. This ongoing project will bring generations of St. Julie parishioners together in the years to come.



Parish Outreach


The St. Vincent de Paul Society has a strong presence throughout our Diocese. Every parish conference has dedicated volunteers working to better serve their community. Eight conferences were awarded funds this year to further their

Dora Hyson, President of St. Lucy's conference, has been involved with the program for 10 years. Clients can visit the conference five days a week from 10:00am-11:45am to seek help through services such as monetary support and groceries for their families.

Once a month, clients can request a bag of groceries, filled with items from the dry food pantry, and a supplemental \$10 grocery gift card. The pantry is stocked by parishioners and through

partnerships with Independent From Hunger, who donated 230 pounds of groceries in July. Clients can also request monetary support once a year to help with costs such as rent and utilities. For the last two years, grants from the Foundation have been the biggest source of support for the conference, allowing them to get more clients back on their feet.

As Dora said, "It's a team effort for us to do this. All we can do is direct them to a certain area to try and get them the help they need."



Apolonia Andre Fund For Liturgical Music

Granting for the first time this year, the Apolonia Andre Fund for Liturgical Music aims to enrich parish worship life and strengthen the community around the Eucharistic celebration. The Pastoral Musicians Music Boot Camp hopes to enhance these elements in choirs throughout our Diocese.

Julie Wind, Director of Music at the Cathedral Basilica, is organizing the event. Musicians and cantors will be able to expand their repertoires and skills through classes such as tuning the choir, picking appropriate music, how to better direct the choir, and more.

The five-day Boot Camp will take place at the Cathedral in January 2015, and will culminate with a Mass where participants will use their newly learned skills. Through this Boot Camp, Julie hopes to show people that "the Cathedral isn't just a place to visit—it's somewhere to learn."

Pastoral Ministry & Training Formation



Catholic on Purpose launched in August 2013 with six pilot parishes: St. Catherine, St. Elizabeth, St. Francis of Assisi, St. Lucy, Holy Spirit, and Our Lady Star of the Sea. The program will focus on evangelization within our Diocese.

St. Catherine chose to focus on evangelization of youth and young adults, and adult formation. Anna Quinones, Chief Development Officer, said, "We want people to be excited about being Catholic again." To do that, Anna has applied to the

Foundation for the last two years to fund various evangelization projects.

This year a new Summer Challenge program was started for youth. The five-day leadership and service camp consisted of Bible Study in the morning and community service in the afternoon. It was a success and two are planned for next summer.

Last fall, to target adult formation, Matthew Kelly came and spoke to over 700 people from

San Jose and surrounding dioceses. Anna hopes the Lisa Hendey event in November will be just as successful.

The Catholic on Purpose team at St. Catherine is getting people excited about being Catholic again and achieving a deepened relationship with Christ. The Foundation is so glad to partner with St. Catherine and the Diocese for this exciting new program.



The Parish Endowment

Parish life offers us the opportunity to fill our spirit with God's overabundance of love and mercy. It is where we share faith, find fellowship, and are renewed through the Eucharist. And all who are called to the table share in the blessings and needs of the community.

One way to strengthen our ministry is through permanent endowment.

What is an endowment?

An endowment is a fund created to support a specific entity or purpose. The fund is invested, and only a portion of the income is used for the specified purpose. Therefore, the fund grows and is available for perpetuity.

How does a parish endowment work?

- It takes \$1,000 to start a new parish or school endowment by parishioner(s)
- · Contributions to the endowment can come from any individual, family, or group(s)
- Contributions may not come from existing parish funds
- Funds are managed and invested by the Catholic Community Foundation
- Endowments are always open for new gifts and bequests
- The distributions will range between 3%-5% annually, and are only for parish use
- Spending of the distribution is overseen by the governing body of the parish

By sharing our gifts now, through an endowment, we are providing for future generations. Imagine knowing that because of your decision today, your parish will receive a grant every year, even beyond 100 years from now. We call this Forever Value.

Parish endowments can have a specific focus like building maintenance, liturgical support, technology upgrades, education, assisting the poor, or general operations. Gifts can take many forms, including cash, securities, pledges over time, real estate, or bequests.

It is the goal of the Catholic Community Foundation to help develop endowments for all of our parishes and schools. We will work with these communities as appropriate to grow the funds.

Summing it all up – A message from Mary

I meet frequently with pastors and community members. Sometimes I get this question: "Why do we need yet one more good Catholic cause; how is this different?" The answer is twofold:

- We focus on developing endowed funds for Catholic ministries, and

Here's one great story of matching: This year we visited the Learning and Loving Education Center in Morgan Hill. This is a Catholic program that educates women while providing childcare and pre-school for their children. The director told me that they need a play structure. The very next day, I got a call from a donor. He said "I have a need, and I think you're just the right person to ask. My college alumni group is looking for a project." Well...I had *just* the right project. This group will take care of everything, providing much needed play space at the center.

That is just one story. We can talk about: the after school homework program at Sacred Heart, the work of Catholic Charities, the pantries and job programs at many parishes, the deep value of Catholic education.

Welcome to my world, where we have the opportunity to provide *Forever Value*, and to invite members of our community to participate. I hope you'll join us.
